

# Purchase tax for distribution boxes



## Overview

Packaging supplies that end up in your customer's hands as part of a sale are generally exempt from sales tax. The box you ship a product in, the bubble wrap cushioning it, and the tape sealing it shut all qualify for exemption in most states because they transfer to the buyer along. Sales tax is a transaction tax levied at the point of sale on the final consumer of tangible personal property. This concept is fundamental to understanding tax exemptions for business inputs. Use tax acts as a complementary levy, applying to goods purchased without sales tax for use, storage, or.
